The RCABC Board is a policy Board, meaning Directors facilitate policy changes that impact the entire roofing industry in BC.

## Board Responsibilities

Board Directors are expected to attend meetings, participate in committees, and bring their expertise to help advance RCABC's strategic policies.

- Four Board meetings per year + the AGM; Special allowances for virtual attendance for out-of-region Directors will be considered.
- Board Directors also sit on the RoofStar Guarantee Board of Directors.
- Opportunities to participate on RCABC's nine standing committees that serve in an advisory capacity to the Board.
- There are no expectations for Directors to serve on the RCABC Executive Committee.
- Board members are elected for a 2-year term, with a maximum of 10 years on the Board.

### Ideal Candidate Profile

RCABC is seeking individuals with diverse backgrounds in roofing, a passion for advancing education, training and performance in the industry, and a commitment to collaboration.

The RCABC Board is comprised of Active Contractor Members and Associate Members. Consideration is given to majority voting shareholders of the Active Member company.

Board Directors must be the company's Corporate Representative and a resident of British Columbia, as per RCABC's bylaws.

# Nomination Process



The RCABC Board is comprised of a minimum of 10 and a maximum of 16 Directors, of which a minimum of 10 are Active Directors and a maximum of 4 are Associate Directors.



Regional representation: A maximum of 6 Active Directors from the Lower Mainland, 2 Active Directors from Vancouver Island, 2 Active Directors from the Interior, and 2 Active Directors from the North.

- ✓ Board Directors must be the company's Corporate Representative and a resident of British Columbia.
- ✓ The election for RCABC's Board of Directors takes place at the Annual General Meeting, typically held in December.
- ✓ Only the Active Member Corporate Representative on record may nominate, and a candidate may not nominate themselves.
- ✓ Nominations from the floor at the AGM for an Active Member Director position are only accepted from the Corporate Representative of another Active Member.
- ✓ In order to participate in the election process (nominate, stand for election, or vote), an Active Member must be a member in good standing.
